Subject: Amendment in the Rajasthan Civil Services (Medical Attendance) Rules, 2013

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan is pleased to make the following rules to amend further the Rajasthan Civil Services (Medical Attendance) Rules, 2013, namely:-

1. These rules may be called the Rajasthan Civil Services (Medical Attendance) (Amendment) Rules, 2015.
2. They shall come into force with immediate effect.
3. In the Rajasthan Civil Services (Medical Attendance) Rules, 2013 - In the existing sub rule (4) of Rule 3 after the existing words "Rajasthan Ayurved University, Jodhpur" and before the words "and any other hospital", the words "/All India Institute of Medical Sciences, Jodhpur" shall be inserted
